

Secondary Scottish legislation enacting the Reform Act


### Contracts subject to the regulations:

- The procuring body is a contracting authority
- The contract is a public works, supplies or services contract
- The estimated value exceeds relevant financial thresholds
- No exemptions apply

### PROCUREMENT ROUTES - COMMONLY USED

# OPEN

### **RESTRICTED**

### FRAMEWORK AGREEMENTS

### **DPS**

- ➤ Single stage process
- Straight forward requirement
- Selection & Award in same process
- Required to evaluate all submissions

- 2 Stage process
- Usually used when high level of returns expected
- Evaluate ESPD & capability/capacity to deliver
- Narrow down companies to invite to full tender

- Companies prequalified
- Quick & Easy compliant route to market
- Support from Framework Provider
- Options re Call OffDirect Award/MiniCompetition

- Similar to Framework
- Simpler access for SMEs
- Open throughout duration
- Call Off mini competition only

Serious Breach of Procurement Policy




### REGULATOR
